Your limits are described as dollar limits "per person/per accident/property damage".

The Bodily Injury Liability limit for "each person" is the maximum we will pay for all damages, including but not limited to damages for care, loss of companionship, loss of society, loss of consortium, loss of services, and wrongful death because of bodily injury sustained by one person as the result of anyone accident. Under the Bodily Injury limit for each person, bodily injury sustained by one person includes all injury, including bodily injury, and damages to others resulting from this bodily injury.

The Bodily Injury Liability limit for "each accident" is the maximum we will pay for all damages, including but not limited to damages for care, loss of companionship, loss of society, loss of consortium, loss of services, and wrongful death because of bodily injury sustained by two or more persons as the result of any one accident. This provision is subject to the Bodily Injury limit for each person.

The Property Damage Liability limit for each accident is the maximum we will pay for all damages to property in anyone accident.
